Justification:

As the first batch of M.Sc. Ag. in these three subjects is passing out this year from AU, Jodhpur. On the other hand the field and laboratory facilities have been created in the college and adequate number of accredited teachers for teaching are available, it is therefore proposed that Ph.D. programme in these three subjects should be started from the academic session 2018-19.
