PROCEEDING OF EXTENSION EDUCATION COUNCIL MEETING HELD ON 16.03.2019 AT VICE CHANCELLOR SECRETARIAT, AU, JODHPUR:

- 1. The Third EEC meeting started at 2.00 PM on 16.03.2019 under the Chairmanship of Dr. Balraj Singh, Honorable Vice Chancellor, Agriculture University, Jodhpur who greeted and welcome all the invited members of Extension Education Council. Thereafter, the Chairman of Extension council acquainted the members about the progress and major developmental activity going in the University.
- 2. As per agenda item, Member Secretary of EEC, Director Extension Education Dr. Ishwar Singh, presented the Annual Progress Report of the Directorate of Extension Education and All the KVKs under its jurisdiction for the season 2018-19. The on & off campus trainings, frontline line demonstrations and sponsored training organized during the season was narrated to the members. The OFTs laid out at farmer's fields and position of R.F. at various KVKs and other developmental activities (purchase of farm implements, repair of house colony and roof-top at Sirohi, All unserviceable items of KVK Sirohi, Nagaur and Jalore have been physically inspected and on declared write off.
- 3. DEE discussed about the site of civil work of ATIC at AU, Jodhpur and Kisan Kaushal Vikas Kendra (KKVK) at AU, Jodhpur, council approved the same.
- 4. In the meeting discussion on funds of infra-structure of KVKs (Jodhpur-II, Barmer-II and Nagaur-II) and progress of civil work of KVK and Farmers hostel has been presented by Secretary, DEE, the amount sanctioned for administrative building of each KVK, (Maulasar, Gudamalani and Phalodi):Rs. 1,43,00,000.00 Amount sanctioned for each Farmers Hostel Rs. 63,00,000.00, (Amount due: Rs. 55,00,000.00).
- 5. DEE presented information of boundary wall construction at KVK, Keshwana and Sirohi under RKVY Project and submission of proposal for boundary wall at KVK, Phalodi to ICAR, New Delhi
- 6. DEE informed the house about the progress of two additional KVKs sanctioned by ICAR, New Delhi in recent past in the jurisdiction area of AU, Jodhpur (Pali & Jalore).

- 7. The developmental work done by AU, Jodhpur and its entire local components in previously adopted Smart Village Neora Road and now Luni village was also briefed to the members by Secretary Dr. Ishwar Singh, DEE.
- 8. All three progressive farmers as a member of council shared their experiences. Shri Navdeep Golechha suggested that all the training conducted by DEE or KVKs their videos should be uploaded on YouTube or other social media so that more people can be benefited, he is also suggested for leaf testing lab and Residue testing laboratory so that farmers can easily get information about nutrient deficiency and also toxicity effect of different agrochemical (Fungicides/Weedicides/insecticides). Shri Thana Ram discussed his viewpoint that if farmers can get Virus free seed and seedlings of Chilli so that the area of chilli can be increase and also discuss the problem facing farmers about cultivation of Quinoa and unavailability of dehusking machine.
- 9. DEE also informed about deposition of money to comptroller Jodhpur in view of the Staff Car for DEE from the Revolving fund of KVK, Keshwana, Jalore as per approval.
- 10. Prof. I. J. Mathur, Ex-Director, DEE and Incharge, ATIC, MPUAT, Udaipur was invited as eminent persons in the field of Extension Education from outside of the University in third EEC meeting. Dr. Mathur appreciated the newly constructed buildings and Farmers Hostels of KVK Phalodi, Gudamalani and Maulasar. He also appreciated the High tunnel technology used for drying of mint, rose petals and chilli. He suggested to preparing plan for selected KVK for getting National Awards.
- 11. Dr I J Mathur suggested to displaying the best technologies of University at KVKs. Member secretary informed that the KVKs are already doing this work through LED display boards. Dr Mathur suggested that KVKs can generate high income through different sources *i.e.*, Nursery, planting materials, increasing seed production. He necessitates installation of seed processing unit at KVKs. He also said that KVK should conduct specific and quality trainings instead of routine trainings and should prepare documentaries of technical works of progressive farmers.
- 12. Dr. S.S. Rajput, Retd. Professor (Agronomy), MPUAT, Udaipur, suggested that seed production of onion is giving better return than commercial onion production. The overall 50% selling of University seeds should be through ATIC Centre.
- 13. The EEC ended with Vote of Thanks by Member Secretary.
